Please review the conditions below carefully, then complete and submit the attached agreement with a sample of your mailing piece for approval.

### **Mailing lists will be provided only when the following conditions are met:**

- a completed agreement must be submitted (see p. 2)
- a sample copy of the piece must be submitted for approval
- your marketing piece must promote the ODA Annual Session
- requests must be received by: **August 28, 2026**

## POLICIES: DISTRIBUTING AND USING MAILING LISTS

The following policies apply to the use of the ODA mailing lists:

1. The names and addresses of ODA members are to be made available only in the form of mailing labels or a list, for **one time** use.
2. Mailing lists are to be made available only to the following groups:
  - Component dental societies of the Ohio Dental Association; other constituent and component dental societies of the American Dental Association; other organizations recognized by the ODA
  - Colleges, universities, and other educational institutions
  - Non-profit service organizations such as the American Cancer Society
  - Reputable companies that sell products and services directly related to the field of dentistry or dental education
3. ODA mailing lists may be used only to promote products or services directly related to the practice of dentistry or the field of professional health care.
4. **Those who wish to acquire the labels must submit this completed agreement AND a sample of their intended mailing piece for prior approval.**
5. Sale of ODA mailing labels/lists does not constitute an endorsement of the organization, company or person purchasing the labels/lists or of the information contained within mailings sent using said labels/lists.
6. Lists will be distributed at the sole discretion of the ODA.
