Dr. Glasper received her bachelor's degree at Spelman College, her DDS degree from Howard University, and completed her post-graduate residency program at the University of Medicine and Dentistry of New Jersey.

Chris Moore is the director of dental services at the Ohio Dental Association and has worked at the association for over 25 years. Chris currently administers the association's third-party payer, peer review, dental practice and regulatory compliance programs and is the ODA's lead staff person responsible for negotiating wastewater disposal issues with the Ohio EPA. Thomas Paumier, DDS

Dr. Thomas Paumier is a general dentist in private practice in Canton and is on the faculty of the Mercy Medical Center Dental Residency Program in Canton. Dr. Paumier recently served on the ADA's Advisory Task Force on Dental Practice Recovery and the ODA's Task Force on Restoring Oral Health Services, which were developed in response to the COVID-19 pandemic. He is a past president and treasurer of the Ohio Dental Association, past president of the Stark County Dental Society, past chair of the ADA's Council on Members Insurance and Retirement Programs, past member of the ADA Budget and Finance Committee, past member of the ADA Council on Scientific Affairs Expert Panel on Prosthetic Joint Prophylaxis, and past member of the ADA/American Academy of Orthopedic Surgeons (AAOS) Expert Panel for Prosthetic Joint Prophylaxis Appropriate Use Criteria. He is a co-author of the ADA Clinical Practice Guidelines on Antibiotic Prophylaxis for Patients with Prosthetic Joints, and Appropriate Antibiotic Use for Endodontic Infections. Dr. Paumier was the 2019 ADA Evidence Based Dentistry Practice award recipient. He is a fellow of the American College of Dentists and International College of Dentists, and a member of the Pierre Fauchard Academy. Dr. Paumier earned his bachelor's degree and DDS degree from The Ohio State University and completed a GPR at St. Elizabeth Medical Center in Youngstown.



Kumar Subramanian, DDS

Dr. Kumar Subramanian has been the president of the Ohio State Dental Board since 2019. He is an endodontist in private practice in Pickerington and part-time educator at Nationwide Children's Hospital. He has been published in peer-reviewed journals and has been an invited speaker in both national and international meetings.
