Dear Friends,

Though we all hoped for a return to normalcy in 2021, we continued to live in a world up-ended by the pandemic. I know this has made big changes to the everyday practice of dentistry and it continues to mean big changes to the ODA Foundation as well. For the second year we have not held a major fundraiser. However, we have continued to improve the oral health of the citizens of Ohio and enhance the dental profession in the state. The Foundation was able to award scholarships to dental students to reduce their student debt, and grants to access to care programs that help the underserved in our communities receive needed dental care.

All of our work is made possible by the generous donations we received from those who believe in our mission. This year, you helped us achieve another goal—chopping off ODA Executive Director David Owsiany's beard which he had been growing since the beginning of the pandemic. With your donations, we doubled our original fundraising goal and Dr. Kimberly cut off David's hideous beard—a win-win for everyone!

Because of the donations received throughout the year at our Circles of Impact levels of giving, the Foundation was able to award the following:

- Three access to care grants, awarded to Good Neighbor House in Dayton, Lake County Free Clinic and Stark State Dental Hygiene Clinic. These clinics serve those in Ohio who struggle to afford and access needed dental care and our funds will purchase equipment that will help provide care for years to come.
- Eight scholarships were awarded to outstanding students from Case Western Reserve School of Dental Medicine and The Ohio State University College of Dentistry. These included two of the Foundation's memorial scholarships – the Dr. E. Karl Schneider II Humanitarian Scholarship and the Forward Ever Scholarship in memory of Dr. R. E. "Jim" Snelson for his leadership in organized dentistry.

While the world has not yet returned to the pre-pandemic normal and the current environment continues to impact the Foundation's revenue, we thank you all for supporting the ODA Foundation. Without you, we would not have been able to carry on our mission in 2021, and we are so grateful you have helped to sustain our grant and scholarship programs. We look forward to 2022 and hope that we can increase our impact on oral health!

ODA Foundation Memorial Scholarships



DR. E. KARL SCHNEIDER II HUMANITARIAN SCHOLARSHIP

Awarded annually in memory of Dr. Schneider, who passed away in 2017 while serving as ODA Foundation chairman, this scholarship recognizes one student for his or her efforts to improve the community. The 2021 recipient was Amber Dalal, D3 dental student at OSU.

FORWARD EVER SCHOLARSHIP

The Forward Ever Scholarship is awarded annually to one student who demonstrates exemplary leadership in organized dentistry in memory of ODA past president and past ODA Foundation chairman, Dr. R. E. "Jim" Snelson whose motto was "Forward Ever, Backward Never." The 2021 recipient was Erin Madar, D3 dental student at CWRU.

2021 Access to Care Grants

In 2021, the ODA Foundation received six grant applications. The Foundation awarded access to care grants to three clinics in Ohio that plan to increase access to dental care.

Good Neighbor House

Dayton, \$2,000

Good Neighbor House serves about 1,000 patients each year who are uninsured or under-insured and unable to afford needed dental care. During the pandemic, many have lost their income and insurance and the clinic sees more requests for dental care as well as more patients who are unable to afford even the greatly reduced sliding fee scale prices. ODA Foundation grant funds help cover costs of needed dental supplies so Good Neighbor House can continue providing care at the lowest possible prices to those who struggle to afford necessary care.

Stark State College Dental Hygiene Clinic

North Canton, \$2,500

The Stark State College Dental Hygiene Clinic provides preventive dental services to about 720 patients each year. The college has been working to upgrade the 25 year old clinic with the new industry standard equipment. The upgrades will improve patient experience and give students the opportunity to practice on equipment similar to what they will use in a dental office upon graduation. With the ODA Foundation grant funds, the dental hygiene clinic will update the remaining operatories that have yet to be upgraded. The clinic also serves an average of 200 hygiene, EFDA and dental assisting students each year as they learn to serve Ohioans with needed preventive procedures.

Lake County Free Clinic

Painesville, \$7,500

The Lake County Free Clinic has been a staple for the uninsured in Northeast Ohio, but due to property and leasing issues, lost their longtime clinic location. In 2022, the organization is working to re-open its dental clinic in a new location and with that comes necessary building upgrades for dental as well as many equipment needs. With the ODA Foundation grant funds, Lake County Free Clinic will be able to outfit their building with necessary plumbing and a new dental chair. Once operational, the clinic will provide dental care to an estimated 300 patients per year.

CALLAHAN MEMORIAL AWARD COMMISSION FUND

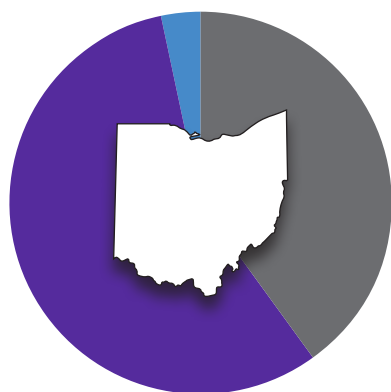

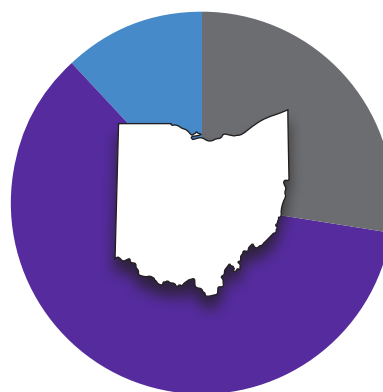
