When faced with fractured or broken down teeth or dentition, often the choices are limited to crowns or extraction and replacement with implants, fixed bridges or removable partial dentures. Limited finances, an aging population and the improvement of direct esthetic bonded composite expand treatment options. During this course, you will learn how to do routine Class 2 posterior composites, direct composite veneers, post and cores with the core serving as a direct interim crown, direct bonded bridges, and salvaging severely fractured teeth with composite. Complex onlays can often replace crowns when a patient fractures one or more cusps. These techniques will help you solve challenges which you will encounter on a daily basis in your private practice. Clinical cases will demonstrate the versatility of well-done composite restorations, giving the esthetics and durability of porcelain with the advantage of simple repair and lower cost. In addition to the clinical considerations of assisting patients with limited finances, available practice management resources such as in-office dental plans and dental credit services will be reviewed.

Are you confused about when it is necessary to use antibiotic prophylaxis for patients with prosthetic joints, cardiac valve replacements, kidney dialysis, AV shunts, transplant patients and other medical conditions? This course will make you confident you are treating these patients appropriately. The use of antibiotic prophylaxis and how it affects bacteremia and distant site infections will be discussed. The biology and physiology of prosthetic joint infections and infective endocarditis as well as the related Clinical Practice Guidelines will be reviewed. The risks and benefits of antibiotic prophylaxis will be demonstrated.

Antibiotics have improved health outcomes since the discovery of penicillin. However, their overuse and misuse has now threatened their effectiveness and led to superbug infections that are untreatable. This course will provide antibiotic stewardship guidance. It will also review the latest ADA Clinical Practice Guidelines related to when antibiotics are appropriate for patients with odontogenic infections as well as prescribing recommendations.

Today's restorative dentist must be a diagnostician not only of the masticatory system but also of the systems that impact it. As our knowledge of systemic involvements broadens, the connection between airway, breathing, bruxism, and reflux is becoming clearer. Whether or not the dentist chooses to be involved in the treatment of airway and breathing issues, parafunctional issues, gastro-intestinal issues or temporo-mandibular disorders, he or she must recognize the effect of these on the restorative dentistry being recommended and completed on a daily basis. We used to be able to limit our activity, and our understanding, to the interaction of the teeth against each other, the occlusion. Those days are departing us quickly. This is not to imply that occlusion is not important, it is very important. The impact of our ability to manage the occlusion can be a primary driver of the stability created by the interdisciplinary treatment. This program will help the clinician evaluate the involvement of occlusion in the etiology of the problems presented by the patient and decide when it is something that should be changed. We will also consider how best to plan for and try out those changes.
